

ORDINANCE 2002-04

AN ORDINANCE ACCEPTING PART OF MT VALLEY AS A CITY STREET

SECTION 1

LEGAL DESCRIPTIONS WILL BE AS DEDICATED FOR PUBLIC USE AS A STREET

SECTION 2

THIS ORDINANCE IS AUTHORIZED BY ARKANSAS STATE CODE 14-301-102 WHICH STATES THAT NO STREET OR ALLEY SHALL BE DEEMED TO BE A PUBLIC STREET OR ALLEY OR TO BE UNDER THE CARE OR CONTROL OF THE CITY COUNCIL UNLESS THE DEDICATION SHALL BE ACCEPTED AND CONFIRMED BY AN ORDINANCE SPECIALLY PASSED FOR THAT PURPOSE.

SECTION 3

THE PERRYVILLE CITY COUNCIL RECOGNIZES THE NEED AND BENEFIT OF ACCEPTING PART OF MT VALLEY AS A CITY STREET

SECTION 4

NEITHER THE ACCEPTANCE OF THIS STREET NOR PASSING THIS ORDINANCE OBLIGATES THE CITY OF PERRYVILLE TO ANY SPECIFIC IMPROVEMENTS TO THIS STREET

SECTION 5

ANY IMPROVEMENTS OR UPGRADES TO THIS STREET WILL BE DECIDED BY THE PERRYVILLE CITY COUNCIL IN THE SAME MANNER IN WHICH ALL STREETS ARE IMPROVED AND MAINTAINED

SECTION 6

THAT ALL ORDINANCES AND PARTS OF ORDINANCES OF A PERMANENT AND GENERAL NATURE IN EFFECT AT THE TIME OF ADOPTION OF THIS ORDINANCE, AND NOT INCLUDED HEREIN, ARE HEREBY REPEALED WHERE THEY ARE IN CONFLICT WITH THIS ORDINANCE. IF ANY SECTION OF THIS ORDINANCE IS HELD INVALID OR UNCONSTITUTIONAL BY ANY COURT OF COMPETENT JURISDICTION, SUCH INVALIDITY SHALL NOT AFFECT THE VALIDITY OF OTHER SECTIONS OF THIS ORDINANCE.

SECTION 7

IN THE INTEREST OF THE PUBLIC THE PERRYVILLE CITY COUNCIL FEELS IT BEING IMMEDIATELY NECESSARY FOR THE PRESERVATION OF THE PUBLIC PEACE, HEALTH, AND SAFETY OF THE CITY OF PERRYVILLE ARKANSAS AND THE INHABITANTS THEREOF, AN EMERGENCY IS HEREBY DECLARED TO EXIST AND THIS ORDINANCE WILL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND PUBLICATION
